Question 1: What can LEN do to support Patient & Public Involvement (PPI) practice?

Have a link on Carers UK and other appropriate websites Run an annual conference Link up with INVOLVE Write articles for like -minded journals Expand the network so that more people are aware of what they do Fund research Public campaign Develop champions e.g. champion for General Medical Council Develop student champions for PPI I have not heard of this group before but hope it goes from strength to strength Training and development

Question 2: How can we demonstrate or evaluate impact of PPI?

Ask qualitative question: How did the PPI in your course change you? Recommendation: PPI should influence the university league tables-lobby The Guardian and The Times

Recruitment and retention of students and changing attitudes of students, ask the question what did they think of patient at recruitment

Being involved right from the beginning when changes have to be made Working with qualified psychiatrist when working with service users and carers in teaching sessions, he learns something new every session Writing scenarios for teaching sessions and OSCE's (objective structured clinical exam) Remodelling a teaching session that works is interesting from a Service user & Carer (SUC) perspective Giving them another spin on their learning making them rethink Own scoring sheet when doing exams Better practice- student grades Writing SU & C module e.g. preparation for practice Team work. We are now a full party to this course Drop-in sessions Integration on courses e.g. managers and SU/C Student evaluation. Podcast, evaluation forms, we could present our evidence at conferences. Pass on good practice

Question 3: What is the impact of PPI on all stakeholders?

Reality

Inclusion, understanding, putting yourself in somebody else's shoes Openness: 1.Transparency 2.to other views i.e. inclusive 3. Access to a variety of skills/experience Credibility Increase in student numbers Restoring the narrative to cases and care Hearts, minds and attitudes (+growing ears to listen!) Increase in compassionate care (& organisations, through time and changing process) Better practitioners in terms of the care they provide and their general appreciation /understanding of value of PPI which improves care

Giving students the time to have more in-depth converstions about patients/carers/ SU life and feelings- what they don't get on ward time usually

Individual clinicians then ripple effect wider....
