Key Tasks and Responsibilities:	<ul> <li>Teaching and Learning</li> <li>Communicate experiences as an NHS user or carer for someone using NHS services.</li> <li>Communicate experiences of living with long term conditions.</li> <li>Provide feedback (after training) on communication and consultation skills</li> <li>Encourage students in small groups to participate and contribute to discussions.</li> <li>Liaison and Networking</li> <li>Liaise with colleagues/students and participate in internal networks.</li> <li>Input ideas as to how patients could be involved in academic programmes and provide assistance in carrying out any agreed plans for patient involvement.</li> <li>Teamwork</li> <li>Collaborate with academic colleagues as appropriate.</li> <li>Attend and contribute to subject group and team meetings.</li> <li>Contribute to the delivery of modules and assessment of students.</li> <li>Other</li> <li>Use listening and interpersonal skills to support student development.</li> <li>Refer students as appropriate to academic colleagues for further help when necessary.</li> <li>Support innovative and creative approaches to teaching and learning support and scholarly activities.</li> <li>Contribute and share ideas with other PCPI participants.</li> <li>Involvement in stakeholder meetings for development of new healthcare related degrees</li> </ul>
